Data Service		means the Supplier Agent role defined as such in the BSC; and, in respect of a particular Metering Point, means the person Appointed in such role for that Metering Point.
DIP Interface		means the data integration platform interface made available by the DIP Manager.
DIP Testing		means the testing required under the BSC in order to become a DIP User, together with any tests specified by the Code Manager.
DIP Manager		means BSCCo or such other entity as is responsible under the BSC for managing the data integration platform.

1 Introduction

1.1. This REC Schedule sets out the processes to be followed to enact MHHS Migration or MHHS Reverse Migration. MHHS Migration and MHHS Reverse Migration involve a number of Market Participants with associated requirements governed within both the BSC and this Code. References to the Supplier Meter Registration Service and Advanced / Smart Data Service Agents are included for information only. Any requirements on the organisations which provide these services are defined and governed within the BSC.

1.2. Paragraphs 2 and 3 define separate processes for:

- a) MHHS Migration enacted at the same time as a Switch;
- b) MHHS Migration enacted as a change of Supplier Agent with no concurrent Switch; and
- c) MHHS Reverse Migration as a result of a Switch, where a Metering Point which had previously been MHHS Migrated is Registered by a Gaining Supplier that is not MHHS Qualified.

1.3. When enacting an MHHS Migration, the Electricity Supplier is expected to initiate an Advanced / Smart Data Service Agent and ~~Metering Equipment Manager~~ Meter Operator Agent (MOA) Appointment at the same time. A Metering Point will be deemed to be MHHS Migrated where a successful Supplier Agent Appointment takes effect with either or both the Meter Operator Agent ~~Metering Equipment Manager~~ and/or Advanced / Smart Data Service Agent being successfully Appointed using a DIP ~~Interface~~ Market Message. As long as at least one appointment is successful, then the Metering Point will have been MHHS Migrated.

For a Metering Point that has been MHHS Migrated (and which has not been MHHS Reverse Migrated), the standard processes for Appointing Meter Operator Agents ~~Metering Equipment Managers~~ shall be followed, as defined in the Metering Operations Schedule. For a Metering Point that has not been MHHS Migrated, the standard processes for Appointing Meter Operator Agents ~~Metering Equipment Managers~~ shall be followed, as defined in the MHHS Transition Schedule.

~~1.5. Each Electricity Supplier shall ensure that its Appointed Metering Equipment Manager re-programmes the clock in each NHH Advanced Meter so that it records time in UTC. This re-programming shall be completed on or before the MHHS Migration effective from date, provided that this activity is completed before the NHH Advanced Meter is used to support MHHS processes within British Summer Time. If reprogramming is not possible within this timeframe, the Metering Asset shall be replaced by the Metering Equipment Manager.~~

~~1.6.~~ 1.5. Associated Import / Export Metering Points are not required to undergo MHHS Migration at the same time. Where the same electricity Metering Asset is being utilised for the measurement of either:

- a) ~~Import~~ by Metering Points registered in the legacy settlement arrangements and Export by Metering Points registered in the MHHS settlement arrangements; or,
- b) Import by Metering Points registered in the MHHS settlement arrangements and Export by Metering Points registered in the legacy settlement arrangements,

2 MHHS Migration

- 2.1. Electricity Suppliers can choose when to migrate individual Metering Points in line with ~~their~~~~the~~ agreed MHHS Migration Plan ~~Migration Plan~~~~individual migration approach and plan~~. There is no requirement for MHHS Qualified Electricity Suppliers to enact MHHS Migration where they gain a Metering Point as part of a Switch.
- 2.2. To facilitate the process, the Supplier Meter Registration Agent will, on receipt of information from the Central Switching Service indicating that a Switch has been initiated for a Metering Point currently settling under legacy arrangements, send site information to the Gaining Supplier via both legacy Market Messages and DIP ~~Interfaces~~~~Market Messages~~ in accordance with BSCP708.
- 2.3. Where an Electricity Supplier chooses not to enact MHHS Migration as part of a Switch, it shall follow legacy arrangements to Appoint Supplier Agents in accordance with the MHHS Transition Schedule and the BSC. Where an Electricity Supplier chooses to enact MHHS Migration, the transmission of an IF-036 Market Message (SMRS Notification of Supplier Agent Appointment and Supporting Info) relating to either or both the ~~Meter Operator Agent~~~~Metering Equipment Manager~~ and/or the ~~Advanced / Smart~~ Data Service ~~Agent~~ will indicate that MHHS Migration has occurred and the Metering Point is now operating under MHHS arrangements.
- 2.4. Where a Related Metering Point relationship exists, as part of an MHHS Migration the ~~Meter Operator Agent~~~~Metering Equipment Manager~~ and ~~Advanced / Smart~~ Data Service ~~Agent~~ Appointments, shall only be progressed through migration in relation to the Primary Related Metering Point. The MHHS Migration status of the Secondary Related Metering Point(s) shall be the same as the Primary Related Metering Point.
- 2.5. As Associated Import / Export Metering Points will be MHHS Migrated independently, the standard Supplier Meter Registration Service validation will be disappplied to enable the Electricity Supplier for the Export Metering Point to initiate a ~~Meter Operator Agent~~~~Metering Equipment Manager~~ Appointment (but subject to Paragraph 1.6).

2.6. Once the Supplier Agent Appointments have been initiated, MHHS Migration will complete unless one or more of the following events occur:

- a) a notification of a Pending Registration is received by the Electricity Retail Data Service from the Central Switching Service for the Metering Point. In this case, the Appointment that had been initiated by the existing Electricity Supplier as part of the migration shall be treated as lapsed;
- b) neither the ~~Meter Operator Agent Metering Equipment Manager~~ nor the ~~Advanced / Smart Data Service Agent~~ accept the Appointment request and there have been no further requests for a Supplier Agent Appointment for that date triggered by the Electricity Supplier; or
- c) a notification of a Cancelled Registration is received by the Electricity Retail Data Service from the Central Switching Service for the Metering Point. In this case, the Appointment that had been initiated by the Gaining Supplier as part of a Switch shall be treated as lapsed;

3 MHHS Reverse Migration

- 3.1. MHHS Reverse Migration is initiated by the Supplier Meter Registration Service where a Metering Point is being settled under MHHS arrangements and a Switch is initiated by a Gaining Supplier which is not MHHS Qualified. Where the Gaining Supplier is MHHS Qualified, it cannot choose to enact MHHS Reverse Migration.
- 3.2. During the MHHS Migration Period, the Gaining Supplier shall check the MHHS status of the Metering Point prior to initiating a Switch, using the Electricity Enquiry Service, to determine whether they are in a position to Register the Metering Point.
- 3.3. To initiate the process, the Supplier Meter Registration Agent shall, on receipt of information indicating that a Switch has been initiated by an Electricity Supplier who is not MHHS Qualified for a Metering Point currently settling under MHHS arrangements, send required information to the Losing Supplier via legacy Market Messages.
- 3.4. Where a MHHS Reverse Migration occurs, the transmission on an IF-003 Market Message (Notification of Reverse Migration and De-appointment) from the Supplier Meter Registration Service to the Losing ~~Meter Operator Agent Metering Equipment Manager~~ (and ~~Advanced / Smart~~ Data Service Agent) will indicate that MHHS Reverse Migration has occurred and the Metering Point is now operating under legacy arrangements. For MHHS Reverse Migration, the IF003 (Notification of Reverse Migration and De-appointment) will be issued instead of the IF037 Notification of Supplier Agent Appointment.
