

REC Code Drafting

Summary of post consultation changes

Data Specification: Data Item Catalogue, Market Message Catalogue and Standards Definition Document

- The Interface code drafting consultation included three artefacts: Data Item Catalogue and Market Message Catalogue (provided in a single document available in html and .bacpac formats) and the Standards Definition Document.
- Some consultation comments related to design issues which we have raised with the Programme Design Team. These are marked in the Consultation Comments Triage Spreadsheet and any updates will be made when we have a response.
- Standards Definition Document updated as follows:
 - Added clarity to explain usage of Source / Target and Primary / Secondary / Always routing is populated for MHHS IFs.
 - Added clarity to Standards Definition Document to highlight that SMRS / REGS, and Distributor / LDSO are the same entity, using different terminology.
- Data Item Catalogue and Market Message Catalogue (HTML and .bacpac) updated as follows:
 - Added a missing Scenario Variant to MM00075 / D0170 (Electricity Retail Data Agent > Electricity Supplier).
 - Fixes to Group Names and Items within DTN ECS Reports MM20061 / D0398 and MM20063 / D0400.
 - Reformatted titles of DTN ECS Reports to "MHHS [TITLE]" as opposed to "[TITLE] (MHHS)".
 - Corrected typographical error in title of MM20059 / IF-003.
 - Corrected an error in MM00240 / D0303 where "Effective from Settlement Date {REGI}" was not showing as Optional.
 - Added Scenario Variant Sources to all new DIP IFs in HTML and .BACPAC files.
 - Corrected an error where numerical fields were showing with a ".0" (HTML only)



Schedule X: MHHS Transition Schedule

- New REC Schedule developed to reflect the parallel running of MHHS and legacy arrangements during the MHHS
 Migration Period. Reflects approach previously discussed with CDWG in 2022 and reconfirmed in September 2023.
- Schedule includes sections covering each MHHS impacted REC artefact and explains how the provisions will differ during the MHHS Migration Period.
- Clarifications provided in triage spreadsheet, minor comments made to formatting, and no other changes made to the drafting.
- Based on consultation comments received, and following further discussion at CDWG on 14 November, we propose
 that the contents of this Schedule will no longer be implemented in its current form. Instead, the contents will be
 incorporated in the impacted REC Schedules and removed at the end of MHHS Migration. This change to the
 drafting approach will be consulted upon during the mop up phase. To facilitate agreement on the drafting (noting
 that the location will change), we are continuing to request that CDWG undertakes an assurance review and CCAG
 approves the draft MHHS Transition Schedule.



Remaining REC Artefacts

Schedule 1: Interpretations and Definitions Schedule

- Schedule covers definitions used throughout the REC.
- Clarifications provided. Updates made to the definition of Data Service and new definition for Data Service Agent and Unmetered Supplies Data Service.

Schedule 15: Metering Accreditation Schedule

- REC Schedule covers approval of gas and electricity MEMs.
- Clarification provided. No changes made following consultation.

Data Specification: EES API Technical Specification

- This artefact defines the content of the EES API and has been amended to reflect the changes required to support MHHS.
- Minor changes made to formatting, data item descriptions, to address issues with alignment to MHHS design requirements and address learnings from the EES build.
