Ofgem View	Ofgem provided a view on M9 approval, noting they are supportive of SIT commencement. Ofgem requested confirmation is provided to Programme participants of the completion of the Elexon Helix work-off plan when this completes on 03 November 2023. Elexon Helix expressed confidence over
IPA Report	The IPA provided a view of M9 approval based on testing assurance activities. The IPA were supportive of the approval of M9 and believe industry are ready to commence SIT. The IPA highlighted several recommendations as per the meeting slides, but stated these did not constitute blockers to the commencement of SIT.
	The Chair, in their capacity as MHHS Senior Responsible Office (SRO), approved the completion of Tier 1 Programme milestone T1-CP-2000 (Control Point 2 - Start of Integration & Test) (DECISION PSG-DEC62).
	Ofgem expressed support for the IPA's view that Programme governance should be kept under review and stated a desire to ensure slick mechanisms to implement fixes as deployment of testing progresses.
	The Chair noted positive views emanating from the CP2 review and the clarity provided on readiness including progression of the work-off plan, the engagement of Programme participants and the endorsement CP2 by the IPA.
