

Level 3 Advisory Groups Updates

Governance group updates

Programme Steering Group (PSG)

PSG 07 February 2024

- 1. Sponsor Update: Of gemadvised DESNZ consider smart metering as ar important factor in future innovation. Progressing MHHS according to the timelines within the Programme Plan is considered essential and DESNZ are keen to support industry parties in ensuring timelines are met.
- 2. Qualification Testing: Responses on the draft Qualification Approach and Plan are due 14 February 2024. Further consultation will be issued soon. Notice of all consultations and response deadlines will be provided in The Clock.
- 3. Migration Updates: A Migration Control Centre (MCC) Framework is under development with workshop sessions to be held in February 2024. Initial principles and know n complexities were shared with the PSG. Participants are encouraged to attend the Migration Working Group to support understanding of migration requirements.
- 4. CR042 Decision: The PSG approved CR042 which changes a Tier 2 migration milestone date.
- 5. Future Readiness Assessments: Changes to upcoming Readiness Assessments were approved which reduce effort required by participants.
- 6. CR036 Decision Appeal: The IPA advised the appeal is ongoing, and reminded parties they are expected to continue activities according to the original decision.

Testing and Migration Advisory Group (TMAG)

TMAG 17 January 2024

- CR037 Decision: The TMAG approved CR037 (Migration Message Processing Choreography Update) was approved for implementation. The updated MHHS Design will be included in Interim Release (IR) 8 on 03 April 2024 and will be deployed into SIT Non-Functional testing scheduled to commence on 02 September 2024.
- 2. SIT Functional Test Scenarios and Test Cases: Theme 8 (settlement and coverage gaps) were issued for review on 12 & 19 January 2024. The Programme will respond to all comments received ahead of the target approval date at the February 2024 SIT Advisory Group (SITAG).
- SIT Functional Test Scenarios and Test Cases (Themes 6,7,9): Themes 6, 7, 8 were issued to participants for review on 15 December 2024 and replies provided to respondents. On 08 January 2024 the SITWG recommended approval. The TMAG approved themes 6, 7, 8.
- Additional Secondary Routing: The Programme advised additional secondary routing testing would be conducted betw een CIT and SIT Functional, led by the Programme Testing Team. The DIP Simulator will be extended for this, and following successful completion, IR5.3 will be deployed.

Design Advisory Group (DAG)

DAG 10 January 2024

- CR039 Impact Assessment: CR039 (Registration Service IF-40 Change) was approved for issuance to IA subject to agreed amendments. Responses are due by 31 January 2024.
- CR040 Impact Assessment: CR040 (Change to NFR E2E1009 for DNO IDNO roles (LDSO UMSO Registrations)) was approved for issuance to IA subject to agreed amendments. Responses are due by 24 January 2024.
- CR041 Impact Assessment: CR041 (Change the format of Market Participant Role Code from Char(1) to Char(2)) w as approved for issuance to IA subject to agreed amendments. Responses are due by 24 January 2024.
- Interim Releases: The next design releases are IR7 on 31 January 2024 and IR8 on 03 April 2024. Subsequent release dates are TBC.
- CR036 Updates: CR036 (Use of Clock Midnight for Appointments and Reads) was approved at the December 2023 DAG meeting and is scheduled for IR7 with implementation in SIT Functional Cycle 2 in June 2024. A Design Resolution Group (DRG) was held 12 January 2024 to refine the redlining of the change that will be released in IR7.

Cross Code Advisory Group (CCAG)

CCAG 23 January 2024

- 1. CDWG Escalations: The CCAG approved the Transitional Text and Interfaces code drafting follow ing a recommendation from the CDWG. It was confirmed that any changes to the approved text as a result of new Programme Change Requests (CRs) or Design Issue Notifications (DINs) which progress despite the Programme change freeze would be reviewed and approved as part of the 'Topic Area Mop-Up' code drafting tranche.
- Consequential Code Change Delivery: The BSC advised qualification and performance assurance code drafting will be discussed at the January 2024 Elexon PAB. The CUSC advised changes to TNUoS charging required as a result of MHHS have been discussed with Ofgem and will be decoupled from CCAG-led code drafting and progressed via standard CUSC governance. CUSC changes are targeted for approval by 30 September 2024 for the start of the charging year.
- 3. Licence Review: The Programme has reviewed potential licence changes required for MHHS and no change requirements have been identified. A consultation will be issued in due course.

Readiness Assessment changes and timelines: Following the Programme Steering Group's (PSG) approval on 7 February 2024, the Programme will re-align future Readiness Assessments with key Programme milestones.

Rather than run a parallel and separate Readiness Assessment 4 exercise, the Programme will use information from the PQS as well as our ongoing monitoring of Programme progress through SIT to assess participants' readiness for future activities. The Code Bodies will separately use the information from the PQS for their Qualification activities as set out in the Qualification Approach and Plan (QA&P), which is the main purpose of the PQS.

In addition to the above, we're combining Readiness Assessments 5 and 6, which were originally due to take place from November 2024 through to January 2025 and from January - April 2025, respectively. The new Readiness Assessment 5 & 6 will now take place from November 2024 through to January 2025, and will focus on:

- Providing a progress check for the start of Qualification Testing
- Participant readiness for M10 (Go-live) and for M11 (start of Migration)
- Providing a progress check for Control point 3/4

This also avoids running two Readiness Assessments at the same time and reduces requests on participants, as outlined in the current version of the Programme Plan.

Code Mop Up 2: Final Review Consultation coming soon: Programme participants will have a final opportunity to review and provide feedback on Code Artefacts in the upcoming Mop Up 2

The Programme will publish the Mop Up 2 Code Artefacts for participant review on 19 February 2024 and comments will be due by 17:00 on 11 March 2024.

All participants are requested to please ensure resource is allocated to complete this review. We'll email more information on this consultation and how to submit comments to participants on 19 February and we'll also share details in The Clock next week, on 21 February





Qualification Working Group Format Post implementation of CR35

One of the proposed changes under CR35 was to introduce an additional working groups for the different qualification pathways under Qualification Advisory Group.

As large amounts of the qualification process remains the same no matter the pathway (e.g., QAD) and the development of these deliverables will be a key focus over the coming months as well as End to End Sandbox being applicable to all therefore introducing additional QWG would likely lead to duplication.

Instead, MHHSP and Code Bodies are proposing there is a single working group under QAG. With agenda being more clearly segmented into sections for all or a specific pathway to allow participants to manage their attendance

Ad hoc working groups for specific qualification pathways being used, if needed, to support review of tailored deliverables e.g., ad hoc LDSO qualification working group to review LDSO test scenarios

This was discussed at January's QWG and received no challenge.





Amending Qualification Milestones to reflect the updated delivery schedule - for QAG feedback

Currently the baseline Programme Plan is not aligned to Qualification POAPs. Code Bodies and MHHSP are working together to update the programme plan. Forecasted dates for LDSO have been included in V5.1 of the programme plan.

Amending Qualification Milestones

Issue Statement


- In Dec-23, the Programme and Code Bodies reviewed qualification timelines to make sure they were still appropriate
- As part of the review, Non-SIT LDSO QT Execution was moved to post SIT Cycle 2 to allow central systems to be further tested; consequently, various milestones require adjustment to reflect these changes
- The scope of this Change Request is to ensure the Programme is accurately tracking and reporting against correct milestones in line with the updated delivery schedule - it is importantly not a change in scope of delivery

High level summary of changes:

- · Amending terminology to wave rather than tranche
- Removal of Tranche 5 to 7
- Amending Non-SIT LDSO QT start date to 01-Oct-24
- · Refresh of milestones tracking readiness to make sure there are appropriate and tracking the right activities
- Forecasted dates for LDSO have been included in V5.1 of the programme plan

Target date of change and next steps:

- · The Change Request will be raised to MHHS PMO, following feedback from QAG
- We anticipate Change Board to review this Change Request in late Feb-24 for validation as a housekeeping change
- If Change Board validate this Change Request as a housekeeping change, a formal Impact Assessment will not be required
- The implementation timeline for this change will be in conjunction with the QA&P being approved by QAG in March-24
