#### **Minutes**

## 1. Welcome

The Chair welcomed all to the meeting and ran over the meeting agenda.

## 2. Work-Off Plans

LC and DM provided an update on SIT Functional Cycle 1 Programme Readiness (as of 29-Feb-24), as per the slides.

AP went through the summary of the work-off plans and T2-TE-0550 position, as per the slides, reiterating that there was an overwhelming vote of recommendation from FTIG 01 March 2024 to support the approval of T2-TE-0550 (SIT Functional Testing Preparation Complete), subject to any work-off requirements.

The Chair asked if anyone had any questions regarding the Work-Off Plans. No comments or questions were raised.

## 3. T3 Milestones

AP provided an update and formal notification of the completion of Tier 3 milestones relating to SIT Functional preparation and any work-off items, as per the slides.

SV asked for clarification of the information given, querying if the approval we were making today was related to Theme 8 test scenarios and test cases, however AP clarified that this was already approved in the inaugural SITAG session and were for SIT Functional Cycle 2 testing. SV had no objections to this response.

The Chair asked if there were any objections to the approval of the laid-out milestones, statuses & work-off plans in relation to SIT F Preparation, as per the slides. No objections or comments were raised.

## 4. Recommendation on approval of milestone T2-TE-0550

KC and LC provided an update and recommendation of approval of milestone T2-TE-0550 (SIT Functional Testing Preparation Complete), as per the slides.

The IPA (TT) provided a recommendation, based on their assurance activities; they support the decision to pass the milestone for SIT Functional Testing Preparation Complete.

SITAG, were requested to advise the SRO on whether T2-TE-0550 (SIT Functional Testing Preparation Complete) should be approved, subject to work-off requirements.

The Chair asked if there were any objections to the approval.
