	The Programme requested approval of the SIT Migration Test Scenarios and Test Cases Theme 1 (Forward Migration) following a recommendation from the SIT Working Group (SITWG).
SIT Migration Test scenarios & Test Cases (Theme 1)	No comments were raised, and the Chair requested any objections to approval, to which none were raised.
	The Chair, acting with delegated authority of the MHHS Senior Responsible Owner (SRO), approved the SIT Migration Test Scenarios and Test Cases Theme 1 (Forward Migration) (DECISION SITAG-DEC11 – recording timestamp 00:05:55).
SIT Functional Work-Off Updates	The Programme provided updates on SIT Functional preparation work-off progress, per the meeting slides. Cohort E & F continue to track for late commencement on 25 March 2024 as previously advised.
	The Programme drew attention to the MHHS-DEL2266 SI Overarching SIT Functional Readiness Report, which contains the latest information on SIT Functional preparation work-off progress.
	The IPA provided updates on test assurance activities per the meeting slides. The IPA highlighted 81 assurance recommendations have been made since April 2023 with the majority implemented and thanked the Programme and participants for their efforts.
	The IPA advised latest activities included:

Programme Milestones related to SITAG	The Programme provided an overview of upcoming Programme milestones relevant to SITAG, per the meeting slides. The Programme requested approval of a change to the delivery date of milestone T3-TE-0092 (Environment Approach and Plan - SIT Non Functional) from 17April 2024 to 15 May 2024.
	The Large Supplier Representative advised the milestone information was useful and requested commentary is provided for all milestones which are 'red' or 'amber'. The representative also requested that milestone changes for decision be clearly highlighted within the meeting papers and appropriate additional context provided where required (ACTION SITAG02-02).
