





Non-SIT LDSO Qualification - Test Scenarios and Test Case Assurance

A walkthrough of the **functional test scenarios and test cases** have been conducted with LDSO programme participants and the material has been uploaded on the shared area for further review and feedback.

QWG have endorsed functional test cases and test scenarios covering business processes:

BP001 – Change of Supplier, **BP002** – Change of Service - Metering Service, **BP003** – Change of Service - Data Service, **BP003B** - Change of Existing Service Appointment Details, **BP005** - Data Processing, **BP007** - Disconnection, **BP008** - Change of Energisation Status , **BP009** – Change of Metering, **BP010** - Change of Registration Data, **BP011** - Change of Connection Type and/or Market Segment, **BP013** - Demand Disconnection Events, **BP016** - Consumption Amendment, **BP019** - Market-wide Data Service (ECS), **BP021** - Industry Standing Data (ECS) and Reports.

Programme participants' comments and feedback have been incorporated in the test case pack.








Focused Subgroups for QT

- Feedback from Programme Participants has been that QWG covers a lot of material and therefore there
 often isn't time to discuss all elements fully
- As it gets closer to Qualification Testing, there is also an increasing need to talk about QT in more depth which will only be applicable to subset of Programme participants
- We are proposing to have to two additional subgroups (one for LDSO and one for Supplier & Agents) which will focus on Qualification Testing only
- Paper day to be 2 days prior rather than 5 as material is likely to be more demo based e.g. ADO or QTF
- Qualification Working Group will focus on wider MHHS qualification e.g. QA&P and QAD as well as items that need to QAG approval
- Timeline for implementation request for approval of the approach at April's QAG and look to set up first QT specific sessions from May

QWG will focus on wider qualification elements e.g. QA&P, QAD as well Sandbox and items that need QAG approval






Environments Approach & Plan, v2.13

- Version 2.12 of the Environments Approach & Plan document was issued for review on 13 March, with the review period closing on 21 March.
- 17 comments were received. None of the comments were 'showstoppers'. All comments have been
 responded to and where required updates made to the Environments Approach & Plan, uplifted to v2.13.
- This document covers the test environment architecture for Non-SIT LDSO Qualification Testing.
- Further iterations of the document will be made in order to include;
 - Non-Functional Testing (including; Non-Functional and Operational testing)
 - Supplier & Agent Qualification Testing
 - Sandbox
- One of the principles of the MHHS Programme is that we sign off documentation when we have the majority of content as 'known'. Further iterations of documents are permissible and will follow the MHHS Programme review process.
- A recommendation to SITAG for the approval of v2.13 of the Environments Approach & Plan has been requested and we can report the outcome of this to QAG.



QAD Consultation

Theme 1 – Document Instructions and Guidance

- This was the first publication of the QAD, hence we received a number of comments on how the document will need to be filled out, and what guidance will be available
- We will provide guidance for the QAD in a similar format to the current SAD/BSA guidance
- The document will be filled out online, including guidance on what is needed for the initial and final submission

Theme 2 – Scope of QAD

- Requests for clarification on how wide the scope is for the QAD submission
- Code Bodies will only be assessing against BSC and REC obligations brought about by MHHS
- This may include upstream/downstream systems not tested as part of SIT/QT functional testing but that interface with in-scope MHHS systems and business processes
- In cases where Participants are placing reliance, they must still complete the QAD with particular focus on any additional testing in their own integrated environment
