## Key Discussion Items

Area	Discussion
	M3 readiness
DBT and M3 readiness	PSG constituency representatives provided a view in turn on readiness in their constituencies to start DBT. Most PSG constituency representatives noted that their constituents were ready to start DBT as per the criteria provided by the Programme, but that there were still uncertainties for delivering DBT as some elements of the Programme had not yet been baselined (e.g. design, programme plan, migration design). Participants felt 'as ready as they can be' given the current Programme position. Some PSG constituency

	representatives noted limited responses from their constituents. The Programme explained that there was no direct dependency on the re- plan for participants to start DBT (but there are likely to be risks relating to DBT completion dates).
	The I&C Supplier representative highlighted that recent government direction on support schemes to support current market conditions would impact their constituent's ability to deliver their plans in the short term. The Programme noted that it was important for Programme Participants to determine how they could deliver against both mandates and to communicate their plans to the Programme as part of the re-planning activity or in Readiness Assessment 2 (this could then help inform Programme activity) (action PSG13-01). Ofgem noted that MHHS was a priority for the industry and that recent market conditions increased the need to deliver the Programme as soon as possible.
	Readiness Assessment 2 (RA2)
	The Programme Party Coordinator (PPC) provided an overview of the purpose and process for RA2. The Independent Programme Assurer (IPA) and PPC explained that the IPA would complete their own assurance alongside RA2, and that the Programme and IPA had recently improved their ways of working to ensure Programme Participants would not have repeated deep dives.
	M3 decision-making
	The Programme provided an overview of the proposed approach for making the M3 decision at November PSG. The Programme noted it was important that any uncertainties had been considered and documented for participants' planning for M3, but that uncertainties would not be a reason not to progress into DBT (e.g. Programme Participants are expected to have high-level plans containing assumptions but not for these plans to be baselined yet, as full plans required a baselined Programme plan)
Programme replan progress	The Programme presented the approach to delivering Round 3 of the re-plan consultation. The PSG decided to make progression to Round 3 consultation on the re-plan conditional on a decision at November PSG ( <b>decision PSG-DEC24</b> ). PSG members queried how the Programme re-plan and a decision on the migration options were related, including the decision-making process and timelines for any decisions ( <b>action PSG13-02</b> ).
	The Programme provided an overview of response rates from Round 2 consultation on the re-plan, noting that the overall number of Round 2 responses was lower than for Round 1, which is disappointing.
	Providers of core capabilities
	The Programme shared the intention to introduce monthly delivery meetings with providers of core capabilities, given their role in the Programme's critical path and importance to Programme delivery. The Programme will work with providers of core capabilities to determine the earliest dates they can deliver in order to commence SIT at M9 (and ultimately to reach M10) as soon as possible.
Delivery of Core	RECCo delivery plan
Capabilities	The RECCo representative presented progress against the workstreams of the RECCo delivery plan. Overall, RECCo were tracking 'Green' against their plan but noted some risks such as dependencies on outputs from the Programme (e.g. baselined design) and concerns of any future requirement to reduce DBT timescales.
	The Programme noted that whilst milestones are reported 'Green', the milestone timings are later than would support the existing MHHS timetable, and in the absence of a new baselined plan, the objective will need to be to explore the earliest dates possible (which is the case for all Participants at this stage).

	<u>MP162</u>
Key Programme Issues	The DCC representative provided an update on MP162. The MDR and capacity role had been separated. The MDR role had progressed through a working group and was continuing to final impact assessment before going to a Change Board. The capacity uplift was progressing ahead of being sent back to Ofgem and wider industry stakeholders. The DCC aimed to align the timelines for both the MDR role and the capacity uplift and to start work on delivery this calendar year.
	Migration
	The Programme aims to have this issue resolved within October. Please see items above for further detail on migration.
Design progress	The Programme provided an overview of progress of the design following the closure of industry review. The updated design artefacts are planned to be released on 17 October 2022 (action PSG13-04).
Delivery dashboards	A PSG member queried how the commercial impacts of the MHHS Programme on settlement were being considered by the Programme following previous feedback. The Programme agreed this was important and to explore establishing a forum where this could be discussed (action PSG13-05).
