

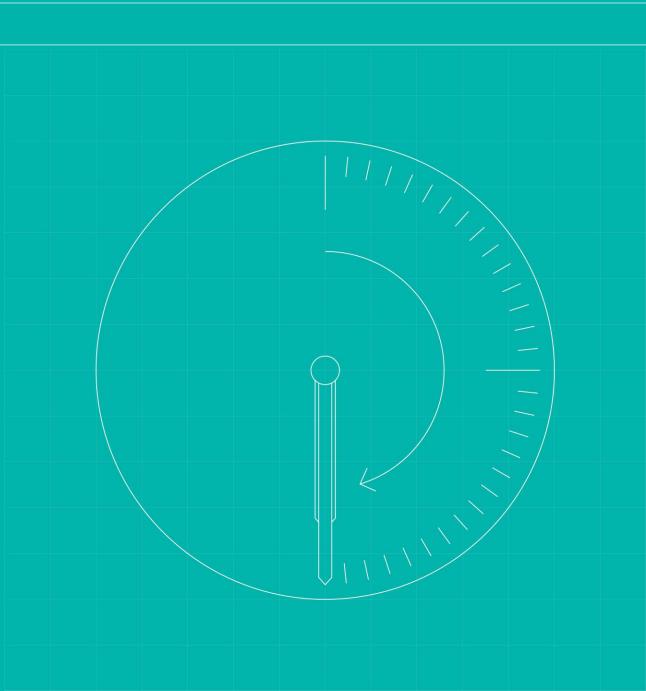

Cross Code Advisory Group (CCAG)

Update from CCAG 26 October 2022

- Regulatory Code Freeze The CCAG discussed how potential code change congestion could be managed and the parties who would need to be involved.
- 2. Delivery of M7/M8 The CCAG discussed previous agreement the M8 (code change delivered) and M10 (start of migration) milestones should be aligned. The group noted there may be a need to bring forward elements of code drafting relevant to M10 t support qualification arrangements.
- 3. M5 Success Criteria and Prototyping Report – It was noted an exercise had been conducted with REC and BSC to demonstrate it is technically possible to draft code legal text based on the MHHS design artefacts. This exercise was successful and the CCAG agreed it supported acceptance of the CCAG's M5 success criteria.
- 4. Consequential Change Code
 Drafting Approach RECCo
 presented a new draft Programme
 Change Request (CR) which seeks to
 allow the incorporation of consequential
 code drafting requirements into the
 CCAG's core code drafting activities.
 The CR will be presented to the PSG on
 02 November 2022 and a decision
 made on whether it is issued for impact
 assessment

Testing and Migration Advisory Group (TMAG)

- Migration Options The Programme provided updates on the progress of the migration options, noting that evidence in support of each option is now being reviewed with Ofgem.

MVC), SIT Execution, Qualification, Migration, adding further detail to the project plan and supporting the Milestone Register, and developing the Replan RAID items following Round 2.





Magnitude of items

The CCIAG's assessment and categorisation method is still under development, however no matters have yet been raised which require significant change to MHHS design artefacts.

The majority of matters currently under discussion by the CCIAG relate to the Retail Energy Code and Supplier processes based on data items which will be removed under MHHS – as such, there are ramifications for participants, and the Programme is collaborating via CCIAG to mitigate impacts. Performance assurance, Industry Standing Data (ISD), and other systems impacts (e.g. entity codes) are also under discussion.

Industry horizon scanning: Summarise items monitored via the Cross-Code Advisory Group (CCAG) horizon scanning process



Horizon Scanning Process

The CCAG collaborate to populate the Horizon Scanning Log and the Programme undertakes impact assessment of each change. Where a change requires actions by the Programme beyond simple monitoring or initial definition, this is entered into the Programme RAID framework with an appropriate action plan and owner put in place.

Industry code changes: 25 – REC: 10, BSC: 7, SEC: 4, DCUSA: 4

Wider industry changes: 5 - HH opt-out, DUoS SCR, code review, microbusiness def







Design Issue and Query Management






High Level Change Management Process

The illustration below provides a high-level overview of how design change will operate.

Change is expected to originate from a number of sources, the new Design Change Triage Group will act as a front door for all change, performing triage to ascertain the next best step. The group will maintain a number of tools to provide the programme and participants with full transparency on all change matters.




Design Groups Governance Structure

Design Group Meeting Cadence


Terms of reference for each group will be proposed for agreement at the initial session. Calling notices for members will be issued via the Clock and the collaboration base.

Illustration of the Design Change Management Process Flow




Design Release Management

Alongside managing the design change process, the SI Design team will be the initial operators of the MHHS release process.

Once the test environments are established, this will become a joint activity with the SI Testing team.

The illustration below provides a high-level view of how release management will operate.



Service Levels for each of the activities will be developed after 2-3 months of steady state operation to establish expected levels of footfall for each process, and the time taken in the resolver stages.

All of the logs, steps and activities will be managed in a transparent manner by the SI, with dashboards based on live positions available on the collaboration base.


