

REC Code Drafting Post Consultation Update Advisory Notes

Mop Up 2

MHHS-DEL-2480

- There were 21 documents within the scope of the Feb 24 REC Mop Up 2 Code Drafting consultation.
- Information on which documents were within scope, the scale of the change made for Mop Up 2 and a summary of the Mop Up changes that were consulted upon is set out in <u>Collaboration Base</u> or <u>Website</u>
- The scope of Mop Up 2 covers the MHHS Programme design up to and including IR7.0. published on 31 January 2024.
- Ahead of M7, the REC Code Drafting will be updated, through a MHHS Programme Change Request, to reflect changes to the design after IR7.0.
- RECCo received 42 comments on the Mop Up 2 consultation across 13 REC documents and we thank parties for these comments.
- Following review of the comments (see consolidated comments log for full details), updates have been made to 10 REC documents.
- A summary of the changes made is set out in the following slides.
- To help parties identify the post Mop Up 2 consultation updates, these have been identified with comment boxes colour coded green* in the updated REC documents.

Schedule 1: Interpretations and Definitions

• One change to definition of Operational to reflect the new definition of this RMP Status for MHHS Metering Points.

Schedule 9: Qualification and Maintenance Schedule

• One change to clarify that Qualification is required separately for Smart MOAs and Advanced MOAs.

Schedule 14: Metering Operations

• One change covering MOA data retention for settlement, one change to clarify data recipients (Supplier and DNO only) of D0383 and D0384 in MOA Auto Appointment/De-appointment process and three minor changes to drafting for clarity.

Schedule 24: Switching Data Management

One typo correction.

Schedule X – MHHS Migration

- One change to remove clause setting out requirement to ensure meters record in UTC as already covered in CoPs 5 and 10.
- One change to update SMRS SLA requirements so that they match the MHHS design.
- One change to remove reference to Smart and Advanced Data Services, which has the effect of extending rules around when MHHS Migration is completed to include UMSDS Appointment.
- One change to reinstate the reference to the MHHS Migration Plan.

Schedule 27 RMP Lifecycle

Four changes to recognise the amended definition of Traded MPAN Status, to reflect the updated MDR design agreed under REC CP-R044 and to clarify how Smart and Advance MOA Role Codes will be updated when sent by the ERDS to the CSS.

ERDS Service Definition

• One change to clarify that only MDR and MOA appointments are notified to CSS (not the Data Service).



Data Specification: Data Item Catalogue, Market Message Catalogue and Standards Definition Document

In several instances, consultation comments have been received which require clarification from the MHHS Programme Design Team. Requests for clarification have been sent and are being considered by the MHHS Programme Design Team. Where RECCo receives a response ahead of the May CDWG review of the updated REC Code Drafting, we will include any changes and seek CDWG recommendation to carry these changes forward for approval at the May CCAG meeting.

We have made the following changes to the Interface Code Drafting (with further detail in the Consolidated Comments Log).

Data Item Catalogue

- DI90016 incorrected listed as CHAR1, with "TRUE" / "FALSE" valid set. To be corrected to CHAR5 in REC Housekeeping Change Proposal.
- Duplicate Data Item DI20133 will be removed, and its existing form (DI50966) retained.
- Duplicate Data Item DI20134 will be removed, and its existing form (DI50967) retained.

Market Message Catalogue

- DI20133 removed from MHHS-REP-003 and MHHS-REP-003A, replaced with DI50966.
- DI20134 removed from MHHS-REP-003 and MHHS-REP-003A, replaced with DI50967.
- Ownership updated to reflect split between BSC, REC, and DCUSA.

Standards Definition Document

• None (subject to request for clarification to the MHHS Programme Design Team).
