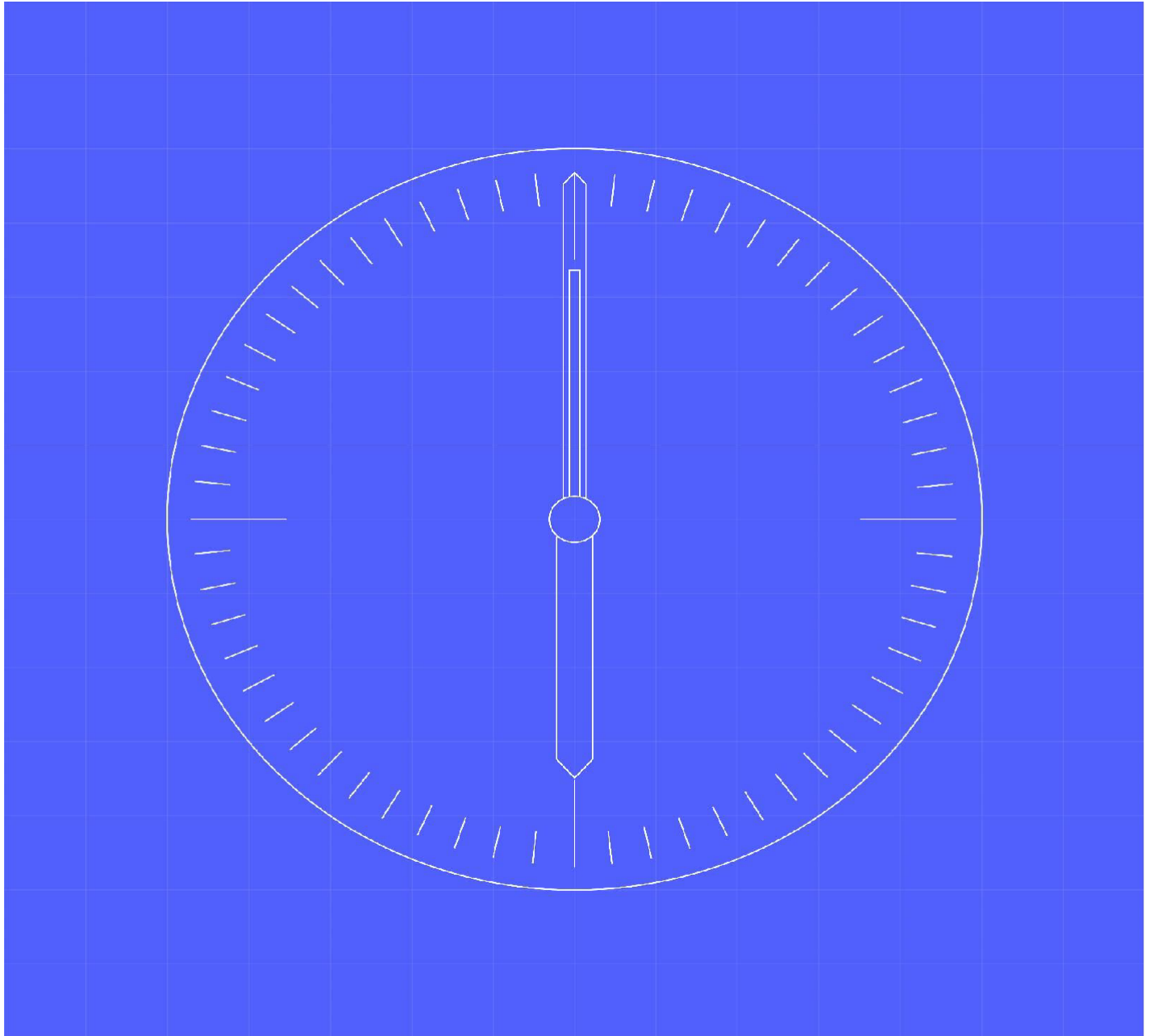

For this to be a reverse migration Test Case, I assume the pre-requisite is an MPAN currently being settled in MHHS. Under what circumstances would a MHHS-qualified Supplier gaining an MPAN that is being operated in MHHS, decide to reverse migrate and operate it under legacy settlement? Also, why the reference to "if the MPAN is being operated under the Legacy arrangements" since an MPAN operated under MHHS arrangements is presumably a pre-requisite for this Test Case?
